Allow Auto population of Consignment and Job Start and Finish Times - During a Delivery Complete event, the Pickup Complete Date Time and the Delivery Complete Date Time is used to populate the Start and Finish times against the Consignment record. The Time Difference is then recalculated and Detail Lines Rated As \$/Hours are updated along with new Rated Amount calculated 2. Toggle Rate Cards to Apply Travel Time - When toggled, the estimated time from Sending Depot to Sender and Receiver to Depot is calculated and added to the new Travel Time field within the Consignment Form. JF-2017	 	<p>OnShip functionality allows for streamlining the operational and administrative processes involved when a freight movement must be charged to two separate Debtors.</p> <p>Typically in this scenario the Sender will pay for the primary movement (linehaul) leg which will move freight to the Destination Depot. A second party (eg. Receiver) will then pay for the Delivery Leg (Destination Depot to Receiver), which is referred to as the OnShip.</p> <p>Previously, the Destination Depot would need to manually create a second Consignment for the OnShip leg, printing and re-labeling the freight for the new Consignment. This process becomes time consuming when the volume of OnShip Consignments is high.</p> <p>The new OnShip functionality allows an original Consignment or Job to trigger automatic creation of an 'OnShip Consignment', based on key criteria being met. When the function is triggered, the OnShip (Child) Consignment will be automatically created and linked to the original (Parent). The OnShip Consignment will use the original Consignment number combined with a suffix of SHP.</p> <p>This function can be triggered from applicable Consignments created directly within Freight, ex-Warehouse from WMS and Web Portal.</p> <p>Freight also has the capacity to manually trigger this process after Consignment creation, provided the Consignment has not already been marked as Delivered.</p> <div data-bbox="384 1641 1469 1720">  Refer associated documentation </div>
